<u>Case Study</u>: A patient with delirium at home being treated with haloperidol who develops worsening agitation due to akathisia.

- 1. Adverse effects of antipsychotics with an alternate vignette of the same case in which the patient develops an acute dystonic reaction.
- 2. Strategies for dosing psychiatric medications in patients who either cannot swallow or cannot absorb, including information about buccal absorption of oral dissolvable medications and alternative medication administration routes, including intramuscular, subcutaneous, and intravenous.
