END-OF-LIFE ETHICS: CULTURAL COMPETENCY

Self-Study ONLINE Course

DESCRIPTION

Using a case study approach, this webinar will address patient and family care at life's end through the lens of cultural competency, offering awareness, skills, and knowledge that take clinical practice a step beyond the commonly accepted concept of cultural humility. Panelists include Karen Bullock, PhD, LICSW, FGSA, APHSW-C; Darcia Simpson, MDiv, CT, PhD; and Gary Stein, JD, MSW.

PROGRAM DETAILS

LEARNING OBJECTIVES

AT THE CONCLUSION OF THIS PROGRAM, PARTICIPANTS WILL BE ABLE TO:

- 1. Discuss moral obligation and respect the autonomy of the patient's conservator
- 2. Examine cultural issues that influence end-of-life care decision making
- 3. Identify ways to demonstrate compassionate and respect for the unique patient/family values, even if these differ from the standard goals of the medical team.
- 4. Identify strategies to assure that advance care plans for patients/clients who identify as LGBTQ are respected by the health care team.
- 5. Explain the importance of staff training to promote knowledgeable and compassionate care towards LGBTQ patients.
- 6. Describe institutional policies that promote respectful and nondiscriminatory care for the LGBTQ community, including patients and families, and hospice employees.
- 7. Analyze and identify ethical solutions related to how spiritual pain complicated by Religious and Spiritual (R/S) abuse impacts the experience of the terminally ill.
- 8. Express and examine R/S abuse in the dying patient and the unique ethical challenges related to possible value imposition that may arise for the medical care team's spiritual and religious views.

PROGRAM OUTLINE

Case 1 (25 minutes)

Surgical intensive care team presents case for consultation regarding moral obligation to respect the autonomy of the patient's conservator to request withholding and/or withdrawal of certain medical interventions.

Case 2 (25 minutes)

Addressing advance care planning with patients/clients who identify as LGBTQ and discussing strategies to better assure that advance care plans reflect patient preferences and are respected by the health care team.

Case 3 (25 minutes)

The patient is dying from a rare cervical cancer. The spiritual pain that typically accompanies terminal illness is exacerbated by the patient's belief system and faith community. The misinformation, stigmatizing messages, shaming, and insensitivity of her spiritual community towards her medical condition is undermining her ability to cope with the dying process. It is also interfering with the healthcare team's ability to care for the patient. Consequently, an ethical exploration of understanding the intersection of end of life, hospice care, and Religious and Spiritual (R/S) abuse is the focus of this presentation.

EXPERT SPEAKERS

Karen Bullock, PhD, LCSW, FGSA, APHSW-C, is the Ahearn Endowed Professor in the Boston College School of Social Work. Her practice interests include health disparities and health equity in serious illness care; aging and gerontology; and hospice, palliative, and end-of-life care decision making. Her research focuses on cancer care, social support for older adults, diversity, equity, and cultural factors influencing health care outcomes. She has served as Principal Investigator and/or Co-Investigator for over \$5 million in federal grant funding focused on equity and inclusion for workforce development, aging, and health network sustainability. Dr. Bullock is a John A. Hartford Faculty Scholar and serves on several national boards and committees, including the Social Work Hospice & Palliative Care Network (SWHPN) as vice-chair and the immediate past chair of the American Cancer Society (ACS) Oncology Social Work Research Peer Review Committee. She is a member of the National Academies of Sciences, Engineering and Medicine Roundtable Committee on Quality Care for People with Serious Illness and a member of the Center to Advance Palliative Care (CAPC) Faculty Advisory Council.

Darcia L. Simpson, BS, MDiv, PhD, CT, is an integral member of the transdisciplinary care team at Hospice of the Western Reserve. As a full-time Spiritual Care Coordinator / Chaplain, she collaborates with physicians, registered nurses, social workers and other healthcare professionals to assess patient and family spiritual needs, identify spiritual problems, develop goals of care and implement appropriate interventions. Additionally, she is an Assistant Professor of Family and Community Medicine at Northeast Ohio Medical University (NEOMED) where she is part of the Reflective Practice in Medicine program. In addition to her 23 years of experience in chaplaincy, spirituality, and hospice care, Dr. Simpson is an active advocate for equal access to health care, geriatric and dementia education, hospice, and end-of-life issues in Northeast Ohio. Dr. Simpson is the 2023 recipient of the NEOMED College of Medicine Faculty award for Medical Ethics and Humanities, and the 2022 recipient of the H. Peter Burg Faculty Award for Excellence in Palliative Care.

Gary L. Stein, JD, MSW, is Professor at the Wurzweiler School of Social Work – Yeshiva University (New York, NY, USA), where he is a tenured faculty member in the master's and doctoral programs. He is also the director of the Gerontology and Palliative Care Programs for MSW students and for clergy, and Continuing Education. He is PI of the study, "Project Respect: Experiences of seriously ill LGBTQ+ patients and partners with their healthcare providers," published in *Health Affairs Scholar* in October 2023. Prof. Stein has been Vice Chair of the Social Work Hospice and Palliative Care Network from 2006

to 2020. He was awarded the Health and Aging Policy Fellowship, a Fulbright Specialist Program Award, and the Social Work Hospice and Palliative Care Network's 2017 Career Achievement Award. Prof. Stein received his JD from New York Law School and MSW from Rutgers University.

MODERATOR:

Timothy W. Kirk, PhD, HEC-C, is Department Chairperson and Professor of Philosophy at the City University of New York, York College, specializing in healthcare ethics with an emphasis on hospice and palliative care. He also holds an appointment in the <u>Division of Medical Ethics at NYU Langone Medical Center</u>. Dr. Kirk is a <u>board-certified</u> ethics consultant with <u>MJHS Hospice & Palliative Care</u>, one of the largest hospice and palliative care programs in New York State, and consults nationally with hospice and palliative care organizations. Together with Bruce Jennings, he is editor of <u>Hospice Ethics</u> (Oxford University Press, 2014).
