

SPIRITUALITY AND HOSPICE CARE IN THE BLACK COMMUNITY

DESCRIPTION:

Studies show that Black Americans are less likely than White Americans to receive hospice care for a variety of reasons. Join Marisette Hasan and Dr. Doneila McIntosh for an important conversation on how spiritual care can play a vital role in engaging and supporting Black patients and their families in hospice care. The program will explore how faith beliefs, while supportive, can pose barriers to earlier admission and use of hospice services. Speakers will also discuss how IDT members can incorporate culturally sensitive and spiritually responsive perspectives into their work to better support Black patients and families.

LEARNING OBJECTIVES:

At the conclusion of this program, participants will be able to:

1. Describe at least three factors that contribute to lower or later hospice use among Black patients and families, including spiritual beliefs, mistrust, and structural barriers.
 2. Differentiate between faith beliefs that support coping and those that may delay hospice acceptance when clinicians do not respond with culturally sensitive communication.
 3. Apply at least three spiritually responsive, culturally sensitive interdisciplinary team strategies to improve engagement, trust, and support for Black patients and families receiving hospice care.

PROGRAM OUTLINE:

- I. Welcome, speaker introductions, disclosure statements, and overview of session purpose. (5 min)
 - II. Current state of hospice disparities: review of recent data on hospice use, timing of referral, and end-of-life inequities affecting Black patients and families. (10 min)
 - III. Spirituality, faith, and meaning making in the Black community: how beliefs, church relationships, prayer, hope, and family decision-making may influence hospice conversations. (12 min)
 - IV. Common barriers to earlier hospice use: mistrust, prior negative health care experiences, lack of culturally concordant communication, misunderstanding of hospice, and perceived conflict between faith and prognosis. (13 min)
 - V. Interdisciplinary practice strategies: spiritual assessment, goals-of-care communication, chaplain involvement, collaboration with community clergy, family support, and culturally responsive care planning. (15 min)
 - VI. Case-based discussion: applying spiritually responsive approaches to a hospice referral conversation with a Black patient and family. (15 min)
 - VII. Key takeaways for IDT members and practice implications for hospice organizations. (10 min)
 - VIII. Question and answer session (10 min)

She is passionately engaged in supporting hospice and palliative care providers and policy advocates to increase access and decrease end of life disparities for patients and caregivers who live in Black and Brown and underserved communities. Marisette is a 2024 SC Palmetto Gold Nursing Award Recipient. This accolade celebrates nurses who exemplify excellence in nursing practice and commitment to the nursing profession. Marisette also serves as the VP for Community Action & Policy with CTAC (Coalition to Transform Advanced Care) and is a Community Co-investigator for the Equal ACP & Equal Space African American Faith Advance Care Planning Research projects led by Dr. Kimberly Johnson.

Doneila McIntosh, PhD, MDiv, LAMFT (she/they) is an Assistant Professor at the University of Georgia, department of Human Development and Family Science with an emphasis in Couple and Family Therapy (CFT). Broadly, Doneila's research examines family processes and well-being, including couples, adults, children and adolescents, and parent-child dyads. Specifically, her research investigates how psychosocial and contextual factors—such as exposure to violence, traumatic loss, and behavioral health—shape family dynamics, mental health, relational well-being across the lifespan. As a therapist, Doneila specializes in grief therapy, primarily supporting youth and families in the aftermath of traumatic loss. Doneila was a recipient of the 2023 Ron Keith Barrett Multicultural Presentation Award from the Association for Death Education and Counseling (ADEC).
